Evaluation period of CMC for Performance evaluation will be as follows:-</p> <p>(i) For the work executed during FY 2017-18 will be for Three Years from date of installation (i.e. from 01.04.2017 to 31.03.2022).</p> <p>(ii) For the work executed during FY 2018-19 will be for Two Years from date of installation (i.e. from 01.04.2018 to 31.03.2022).</p> <p>(iii) For the work executed during FY 2019-20 will be for One Year from date of installation (i.e. from 01.04.2019 to 31.03.2022).</p> <p>(iv) For the work executed during FY 2020-21, performance evaluation will be done on the basis of successful installation & commissioning till date.</p> <p>II. Failure to achieve any one of the above will lead to disqualification/rejection of Bid even if bidder is eligible for participation.</p> <p>III. Performance of Agency will be evaluated on similar work awarded by JREDA.</p>
